Pursuant to Regulation 30 read with Part A of Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (including any statutory modification(s), amendment(s) or re-enactment(s) thereof for the time being in force, we hereby inform you that IncrementX Private Limited ("IncrementX"), subsidiary of Vertoz Limited ("the Company") has issued 2,000 Compulsorily Convertible Debentures ("CCDs") aggregating to INR 20,00,00,000 to certain identified individuals on Private Placement Basis.

We hereby further inform that the Company has entered into a Put and Call Option Agreement ("the Agreement"), which entitles the Company a right to acquire 2,000 CCDs by exercising the Call Option and a right to the investors to require the Company to acquire the CCDs pursuant to the put option.
